

Loyalty & Referral Commissions

Purchasing through this website may reward you with loyalty and/or referral commissions.

Your first order will generate a 3x3 Rewards Matrix which can pay you commissions on all commissionable orders within your matrix. All commissionable products are issued a Commission Value-CV, and it is on the CV that commissions are calculated and paid.

Commissions are paid monthly, by check, on or about the 10th of each month on the previous month's orders.

To qualify for commissions, you must have placed a personal order for any commissionable product during that month.

You can earn 30% Fast-Pay Commissions on every new member's order you refer; PLUS, you can earn 10% commissions on all 3 levels of your 3x3 Rewards, Spill-Over Matrix on all reorders in your matrix, even those that spill into your matrix; PLUS, you can earn a 50% check match on all commissions earned by all those you refer—even if they are 100 levels deep—and if members do not qualify, the matrix will compress paying upline qualified members.

If you fail to place an order in any given month, you will not be qualified for commissions that month the matrix will compress and commissions paid to your upline qualified members.

To re-qualify for commissions in future months, simply place a qualifying order in any given month..
